# 1. Healthy! Capital Counties Purpose & Progress

The progress of the project to date was reviewed. The data has been collected and staff developed a draft Health Profile Report for review and recommendations.

  - a. The members in attendance were given a draft Community Health Profile and the group as a whole reviewed each section of the report. Explanations of each section of the report was provided by project staff (Anne, Cassie, and Ross), and suggested revisions were noted throughout each section discussion. The members in attendance agreed that no major revisions were needed to the report, but project staff would make the minor revisions that were recommended by the group.
